# **RESOLUTION #122**

# APPROVAL OF ACQUISITION OF AN EASEMENT BY THE MONROE COUNTY WATER AUTHORITY PURSUANT TO \$1096 (6-A) OF NEW YORK'S PUBLIC AUTHORITIES LAW

**WHEREAS,** the Monroe County Water Authority ("Authority") is responsible for the existing water main that provides water service to 10221 Alleghany Road located, in the Town of Darien; and

WHEREAS, the acquisition of one (one) easement is necessary for the operation, maintenance and future replacement of the water main; and

**WHEREAS,** the easement, is located along the frontage of 10221 Alleghany Road (Tax Acct. No. 7.-1-42.111), which is owned by William F. Sweet, Sr. and Gloria D. Sweet, and is approximately 468 x 15 along the Alleghany Road frontage, and

**WHEREAS,** the acquisition is necessary to allow for the operation, maintenance and future replacement water main which will allow the Water Authority to continue to provide potable water supply and fire protection to this property and the property owner has agreed to voluntarily grant the easement to the Water Authority; and

**WHEREAS,** §1096(6-a) of New York's Public Authorities Law requires the Water Authority to obtain the prior approval of the above-referenced acquisition by the Town Board.

# **NOW, THEREFORE,** let it be

**RESOLVED,** that the Town hereby approves of the Water Authority's voluntary acquisition of easements over 10221 Alleghany Road in accordance with §1096(6-a) of the New York Public Authorities Law and be it further

**RESOLVED** that a copy of this resolution be provided to the Monroe County Water Authority.

The above resolution was brought forth by Supervisor Hagelberger and duly seconded by Councilman Ferry.

#### Notifications

The Intercommunity Medical Building has been sold and all outstanding debts have been paid. The Board of Directors is in the process of dissolving the corporation and making the distribution of funds to the affiliated towns. The Towns of Attica, Bennington, Alexander, Darien, Sheldon, Orangeville, Bethany and Middlebury will share in the closeout fund distribution. The estimated Darien share is \$46,000.00.

Election Day is Tuesday, November 8<sup>th</sup>. Polls will be open from 6:00AM to 9:00PM at the Town Hall. Electing Government Officials is your responsibility; please exercise your right to vote.

There will be Voter Registration held here at the Town Hall on Saturday, October 8<sup>th</sup> from 12PM – 4PM and again on Saturday, October 15<sup>th</sup> from 2PM – 9PM.

The Town of Darien Water District No. 6 application to USDA Rural Development for grant and loan funding has been accepted. The application is now in the funding process. This project was not funded in the September funding cycle. Next funding cycle is expected in the first quarter 2017. Over two hundred postcards have been received at the town hall from property owners to date with their position on this water district and another hundred have arrived in the post office box to be picked up. These postcards are not a vote but provide guidance to the Town Board of the desires of the property owners. A count of "for" or "against" of postcards received by the end of October will be announced at our November meeting. If you have not returned your postcard, please do so. If you any reason you did not receive a postcard or cannot locate it, see the Town Clerk for another postcard.

Thank you to the Darien Fire Hall for allowing us to use their facilities to hold the public information meetings.

HIGHWAY – did work on County Line Road, replaced 6 culvert pipes and found 2 more that would like to be worked on before winter. Mowing is about half done with the fall pass. Sealed Smithley and Griswold Roads. Have been doing a lot of work with other Towns. O'Conner Road bridge is being worked on by the County. A mowing tractor is in the shop getting tranny work done and all the trucks have been in for their inspections. The salt is being hauled in. The loader auction will be done in 2 weeks; required a deposit from any bidder and placed terms like we used in our bid openings. The auction site usually gets the money in a week. The generator had to have some work done and a part is coming. Have received a letter from the Sheriff's Office pertaining to the intersection at County Line/Sumner/North which was from complaints. The County over cedes the Town as far as signage and that corner is handled by Erie County.

ATTORNEY – working with the ZEO on zoning issues and met with Steve Mountain, Dave Hagelberger and Alice Calmes on September 30<sup>th</sup> to review the proposed Water District #6

ENGINEER – Steve Mountain has been busy with the proposed water district
