PERMIT APPLICATION FOR FIREWORKS DISPLAY

This application shall be executed in several counterparts, each of which shall be deemed an original, and all of which shall be deemed to constitute a single application.

Permit Requirements:

- All applications for permits for the public display of fireworks shall be made ***at least five (5) days*** in advance of the date of the display
- The permit shall contain provisions of the actual point at which the fireworks are to be fired.
- All uses of all fireworks displays in areas of public assembly shall be approved by the Town of Darien. The Town of Darien shall determine that appropriate measures are established to provide:
 - Acceptable Crowd Management
 - Security Fire Protection
 - Other Emergency Services
- Before the performance of any display, the permittee shall submit a plan for the use of fireworks to the Town of Darien. See below for plan requirements.
- After permit has been granted, the permittee shall keep the plan available at the site for safety inspectors or other designated agent of the Town of Darien.
- The Town of Darien reserves the right to have fire apparatus on site at any event it deems in its discretion to warrant such action.

- That the display is twenty (20) feet from the nearest permanent building, public highway or railroad or other means of travel.

- That the display is at least fifty (50) feet from the nearest above-ground telephone or telegraph line, tree or other overhead obstruction.

- That the display will have the audience restrained behind lines at least one hundred fifty (150) feet from the point at which the fireworks are discharged.

- That the display will have only persons in active charge of the display be allowed inside these lines.

- That the display will have all fireworks that fire a projectile shall be so set up that the projectile will go into the air as nearby as possible in a vertical direction. *(Unless such fireworks are to be fired from the shore of a lake or other large body of water, when then they may be directed in such manner that the falling residue from the deflagration will fall into such lake or body of water.)*

- That the display will have at least two (2) soda-acid or other approved type fire extinguisher of at least two and one half (2 ½) gallons capacity each and shall be kept at as widely separated points as possible within the actual area of the display.

- The applicant agrees to provide the Town of Darien with a copy of its general liability policy that provides not less than:

- One million (\$1,000,000) liability limit for fifty (50) people or less in attendance of the event, for any one occurrence.
- Five million (\$5,000,000) liability limit for fifty-one (51) people or more in attendance of the event, for any one occurrence.
