Mazurek: Mr. and Mrs. Mazurek of 9772 Fargo Road, Corfu, NY submitted an application for a variance to construct a pole barn forward of the house at 663 County Line Road, Alden, NY, Tax Map #13.-1-31.11. The applicants indicated they did not intend to live in a trailer in the barn, they intend to build a house and the barn is for personal not commercial use. The public hearing will continue November 28, 2016 at 7:35p.m. Notices will be provided to Erie County residents and posted on website.

Dundon: Rob Dundon of 12705 Uebelhoer Rd, Alden, NY submitted an application for a variance to construct a pole barn forward of the house at Tinkham Road, Darien, NY, Tax Map #15.-1-52.11. Dawn Mark made a motion to forward to county planning. Jane Oles second. All ayes. The application will be forward to County Planning. There will be a public hearing on November 28, 2016 at 7:45p.m.

Bizub: David Bizub of 450 Seven Day Road, Darien Center, NY, Tax Map #13.-1-12.12 submitted an application for a variance to construct a carport forward of the house. Jim Burkhardt made a motion to forward to county planning. Chet Olszewski second. All ayes. The application will be forward to County Planning. There will be a public hearing on November 28, 2016 at 8:00p.m.

Dawn Mark made a motion to adjourn the meeting. Ben Kolhagen second. All ayes. The meeting was adjourned at 8:27pm.
